CHAPTER 1

INTRODUCTION

1.1 Background of study

Nowadays, in a competitive environment, every organization, management and sector, or smart business, feeds low-growth and growth operations by adopting lean manufacturing practices. The lean manufacturing system is a methodology that objective to minimize waste in manufacturing system while maximizing productivity and creating an environment for continuous improvement. The 5S management method is one of the first tools that can be applied in an organization embarking on the culture of continuous improvement. The implementation of 5S describes the first guidelines to eliminate waste and keep an effective, secure and clean working environment. 5S was introduced by Taiichi Ohno, who invented the Toyota Product System, and Shigeo Shingo, who also put forward the Poka-Yoke idea.

Most industries in Malaysia use the 5S, 6S, and 7S management method as an additional step towards managing Safety and Spirit in their workplace. The 5S management method comes from five Japanese words that begin with the letters "S". The words that make up the 5S management system are Sort (Seiri), Set in Order

(Seiton), Shine (Seiso), Standardize (Seiketsu), and Sustain (Shitsuke) and are already upgrading with Safety and Spirit to improve the level of awareness and motivation an employee and increases the efficiency of the production operation process. Safety procedures and safety training are useful in reducing accidents, while team Spirit promotes and motivates team members to work better in an organisation. The main focuses of the 7S management method are to improve productivity by eliminating or reducing the losses associated with managing operations and improve the morale of the employee also eliminates processes without added value and improves the development of standardized work methods.

Lean Manufacturing is a management philosophy derived mainly from the Toyota Production System, which seeks to eliminate "Muda" waste in a manufacturing system. It sees many kinds of waste, including the waste of excessive human movement or motion, and seeks to incorporate each phase of production into a comprehensive and effective method to decrease expenses and enhance general revenue. Seven wastes that are overproduction, inventory or stock, motions or movement, defects, over-processing, waiting and transport are recognized in the lean manufacturing system.

The 7S management method is easy to use and requires no technical analysis. It can be implemented in all kinds of businesses, from manufacturing plants to offices, small businesses, and multinationals, as well as in the private and public industries. The awareness and understanding the concept of the 7S management method is very important for employees to apply to their field to ensure the 7S implementation management method effective and efficient in an organization.

The purpose of this research to study the 7S management method system to eliminate and reduce waste in improving the standard operation management system in the circulation section at UTeM library including borrowing and returning service. Every organization has own approach to conduct the management system to ensure the quality of the management system always ahead and have a continuous improvement. Besides that, in the effort of implementing of 7S management method to improve the standard of the organisation which requires the cooperation among worker. According to Alberto, et al. (2010), clarifies 5S is strongly linked to certain operational efficiency measures those relating to the quality and productivity of the product or service.

1.2 Problem Statement

7S management method concept is a new Standard in World Class Workplace Organization. Most industries in Malaysia implements 5S, 6S and 7s program method as an added step towards the Safety and Spirit management in their workplace. The main purpose of the 7S program method is to improve productivity with eliminates or reduces the waste occurs in operation management while gaining good morale toward the employee. Besides that, 7S also function as the first critical step in any improvement program with helping the analysis process and improvement setup operation. 7S management method system helps to grow the value added to each worker and environment of workplace organisation. However, there are many organisations that still unaware of the concept of 7S as a strategy conceived to support the Total Quality Management (TQM).

This research also will determine how far the level of awareness about 7S management method and researcher also suggest improvement action in creating awareness towards employees. The majority, the knowledge about how important of 7S management method system is still low among the community.

These problems may arise due to a lack of understanding about 7S management method as an instrument in improving the standard quality operation management system to be more efficient and effective in an organisation. Refer to Dwi Lindy (2015), libraries faced with a declining budget and a complex library system. Libraries need an effective technological assistance to manage traffic. According to Mehra, (2014), the 5S methodology is the best tool for generating attitude change among employees and allows for engage in important activities in the workplace. But, the implementation of this universally accepted and difficult. This system is certainly not an easy task, as it requires the creation of new cultures, changing attitudes and good work environments. In the same time to implement the new instrument is take time and costly to apply and adopt the method towards organisation in short term. Thus, this research is about the significant of 7S management method and how to make continuous improvement approach in quality of circulation section at UTeM library.

1.3 Research Question

The research process is constructed by followed the iron triangle that consists of three main elements which title is, research question and research objective. Before the researcher form the research question, the researcher needs to understand the topic and how to achieve the objective. However, in order to complete the study, the researcher has constructed the research question below:

- What is the understanding of 7S management method in circulation section UTeM library?
- 2. What are the level of awareness and motivation UTeM' staff towards 7S management method in circulation section UTeM library?
- 3. What are the suggest improvement action in creating awareness towards employees in circulation section UTeM library?

1.4 Research Objective

There are three objectives that need to be achieved to complete these studies which are:

This research purpose to achieve the goals and objective which is to examine several variables that effect on employees understanding and the level of awareness and motivation of employee to become more productive and efficient in an organisation. Moreover, the research also needs to suggest improvement action in creating awareness towards employee of 7S as a new management method system that will make add value for other researchers to use as reference on other related research. Therefore, the researcher outlined of the scope as the response to this study is a focus of operation management system in the circulation section UTeM library.

Next is the primary will be a focus on the actual current status of 5S approach implementation and included all organisation or companies was implementing the 7S method and those organisation or companies that already adopting and applied 7S practices in the operation management system. This study will use the survey questionnaire to comprise of three main sections which are address demographic information of staff in UTeM. After that, the researcher will evaluate the understanding of 7S management method system, determine the level awareness of employees about this program and suggest improvement action in creating awareness among UTeM staff. The data analysis will be carried out by using SPSS software version 23.

1.5.2 Limitation of the Study

This research is focused on gaps in the understanding of 7S management method system in the circulation section at UTeM library. In the next research will explore and study new items for the effectiveness of this program.
