One of the educational sectors implementing MS ISO 9001:2000 in their organization is Kolej Universiti Teknikal Kebangsaan Malaysia, KUTKM. In this research, the benefits that the institution gains by implementing this Standard have been discussed and analyzed in detail. The research has been made to realize whether the institution gains the benefits of implementing the Standards or not. The data for Teaching and Learning Activities available in KUTKM have been collected and been discussed in detail. The data of customer's satisfactions have been gathered to determine the effectiveness and the smoothness of the implementation of MS ISO 9001:2000 in KUTKM. 1.1 GENERAL RESEARCH

ISO 9001:2000 is a very important method used in the industrial sectors nowadays. ISO 9001:2000 is the current version of the Standard. It was revised in the year 2000. Past versions of ISO 9000:2000 included ISO 9002:2000 and ISO 9003:2000, but those are no longer in use. Companies are now only registered to MS ISO 9001:2000. There are two main aspect that determines why most of the industries are implementing MS ISO 9001:2000 in their organizations. The first main aspect is because of the market pressure and the second aspect is because of the internal effectiveness and productivity benefits.

As most of the industries needed MS ISO 9001:2000 to their improvement and effectiveness process, there are also others sectors can implement it in their organization. Although MS ISO 9001:2000 is originally intended for manufacturing industry, it has attracted interest in others sectors of service industries, including education. To date, a small number of educational institutions in Malaysia have registered to the standard, including Kolej Universiti Teknikal Kebangsaan Malaysia (KUTKM).

The main purpose of the project is to make a research of educational sectors implementing MS ISO 9001:2000 in their organizations. Then, the research will be documented in this project report on some aspects. The way

how to conduct the research will also been identified in the other chapter in this project.

In order to conduct the research, some task should be done. The information has been taken from the Quality Assurance and Accreditation Center, Academic Management Office and other resources such as reference books, internet sources and from the journals available before the research been conducted. By gathering all the resources, we can collect the data of the research that related to the project.

The research of MS ISO 9001:2000 will be done in Kolej Universiti Teknikal Kebangsaan Malaysia (KUTKM). The reason of why the university has been chosen is because the university has already implemented the ISO 9001:2000 in their organization. In this project, the benefit that the organization could gains will be discussed. The use of MS ISO 9001:2000 will be studied according to implementation in the higher institutions and the design of the experiment that will be handled after will be done to investigate the effectiveness of the standard.

Besides that, in this research, the relationship between the major keyword in the company and in the higher institutions must be determined in order to get better understanding of implementing the ISO 9001:2000. The examples of the major keywords in the companies are such as product, customers, managers, workers etc. So the meaningful of all the keyword should be related with the meaningful of the keywords available in the higher institutions sectors.

In this project also, the criteria of implementing MS ISO 9001:2000 also had been determined. The criteria that have been recognized are:

1.2 RESEARCH SCOPE
